## Meeting Minutes Regular Meeting

02/13/18

### Call to order: 4:30

- One Day License -Gardner Ale House —Food Truck Festival – Beer & Wine, 6/9/18, 4:30pm-8:30pm –
- Rick Walton present for Gardner Ale House, same configuration 20x40 tent area to be licensed. Chair asks that the food truck festival has expanded toward GFD. Member Arsenault asks is it the whole street. Mr Walton advised that the area of the food truck festival will be City Hall Ave to Nichols , to pleasant Street to Knowlton Street. Member Arsenault asks how GFD will be able to get through. Mr. Walton advised that GFD is part of planning meetings and will be able to make room to get through if calls come in. Chair asks Mr. Walton to amend the license to accommodate the change of time from 4:00pm to 4:30 to reflect the change in detail officer needed. Atty. Binder asks if motion is needed for One Day approval. Chair agrees. Atty Binder makes motion Member Arsenault approves and motion is carried One day license approved as listed.
- MWCC Foundation –One Day License-Inauguration- Beer & Wine, 3/28/18 , 4:00pm-7:00pm . Chair asks if anyone present to speak on behalf of MWCC regarding license. Notes that no one is present. Chair reviews the license as McNallys catering. Chair notes that Campus Police usually monitors MWCC events. Nothing to note that would stand out to question. Member Arsenault makes motion to accept one day as listed, Atty. Binder seconds motion. Motion carried to sign and issue license as noted.
- Common Vic- Faith Lutheran Church . Chair notes that common vic is for food related functions. Chair passes for signature for all members.
- Hannaford –Change of Manager-Robert Eugene Page. Chair notes party not in attendance, reads through the details of the license. Passes to members noting that he does not see anything that stands out. Chair asks if Hannaford submitted paid receipt. Atty Binder makes motion to approve change, Member Arsenault seconds, Chair notes License change approved.
- ABCC Annual Report- Signature needed Chair reviews the paperwork. Member Arsenault questions what the special legislative license is, Coordinator Daigle advises that Gardner Ale House has that classification because they not only have a pouring license but a brewing license as well. Atty. Binder moves to accept ABCC annual Report. Member Arsenault seconds. Motion carried Annual Report Approved.

- New Business: WA Lottery offering KENO monitor for Blazer's Package Store- any objection needs to be placed in writing within 21 days of 1/23/18. Chair questions whether we need approval or just informational. Coordinator Daigle advised only informational. Atty. Binder interjects that there would be objections raised if there were outstanding violations.
